

TOTO Game Rules (TOTO Match)

w.e.f. 3 June 2025, 00:00 hrs



In accordance with Section 70(1) of the Gambling Control Act 2022, the Gambling Regulatory Authority of Singapore approves the game rules in respect of the game “TOTO (TOTO Match)” as set out in this document by Singapore Pools (Private) Limited.

GAME RULES FOR THE TOTO GAME (TOTO MATCH) ("TOTO MATCH GAME RULES")

The following Rules are laid down by Singapore Pools (Private) Limited ("Singapore Pools", "we", "us" or "our") for the TOTO MATCH.

1. Objective

- 1.1 The TOTO MATCH refers to a category of bet types whose results are based upon the corresponding draw of the TOTO Game¹. In order to place a TOTO MATCH bet, you will have to purchase a lottery ticket in person for a betting selection made under a selected TOTO MATCH bet type offered by Singapore Pools for a particular draw. There are differing TOTO MATCH bet types that Singapore Pools may offer from time to time, and each bet type has different winning criteria and winning payouts. In general, in order for your TOTO MATCH bet to qualify for a winning prize, your selected number or set of numbers on your lottery ticket must match the Winning Numbers drawn during the particular draw of the TOTO Game for which your lottery ticket is valid.²

2. How to Play

- 2.1 Placing a bet on TOTO MATCH essentially requires you to select one (1) to four (4) different number(s) (depending on your bet type) for the purposes of matching with the Winning Numbers drawn for a particular draw of the TOTO Game. You will win a prize if there is a successful match between your selected number(s) and the Winning Numbers drawn.
- 2.2 A TOTO MATCH bet is also referred to as an "**Entry**". There are different types of Entries that you may purchase for TOTO MATCH:

MATCH ADDITIONAL NUMBER Entry:	This requires the purchase of a bet on a single selected number from one (1) to forty-nine (49) (both numbers inclusive). You will win when your selected number on your lottery ticket matches the Additional Number drawn .

Example: You select the digit "39". You will win if the Additional Number drawn is "39".

MATCH 2 Entry:	This requires the purchase of a bet on a selected set of two (2) numbers from one (1) to forty-nine (49) (both

numbers inclusive). You will win when your selected set of 2 numbers on your lottery ticket **matches 2 of the Winning Numbers (excluding the Additional Number) drawn.**

Example: You place a bet on “1” and “6”. You will win only if the Winning Numbers (excluding the Additional Number) drawn contain “1” and “6”. For example, you will win where the Winning Numbers drawn are “1”, “3”, “6”, “11”, “23”, “34”.

MATCH 3 Entry: This requires the purchase of a bet on a selected set of three (3) numbers from one (1) to forty-nine (49) (both numbers inclusive). You will win when your selected set of 3 numbers on your lottery ticket **matches 3 of the Winning Numbers (excluding the Additional Number) drawn.**

Example: You place a bet on “1”, “6” and “34”. You will win only if the Winning Numbers (excluding the Additional Number) drawn contain “1”, “6” and “34”. For example, you will win where the Winning Numbers drawn are “1”, “3”, “6”, “11”, “23”, “34”.

MATCH 4 Entry: This requires the purchase of a bet on a selected set of four (4) numbers from one (1) to forty-nine (49) (both numbers inclusive). You will win when your selected set of 4 numbers on your lottery ticket **matches 4 of the Winning Numbers (excluding the Additional Number) drawn.**

Example: You place a bet on “1”, “6”, “23” and “34”. You will win only if the Winning Numbers (excluding the Additional Number) drawn contain “1”, “6”, “23” and “34”. For example, you will win where the Winning Numbers drawn are “1”, “3”, “6”, “11”, “23”, “34”.

3. Placing your bets

- 3.1 You will be able to place your TOTO MATCH bets in person at our betting outlets or with our authorised retailers.
- 3.2 TOTO Match bets may be placed from as early as fifteen (15) days up to half an hour before the conduct of the TOTO Game draw. If a bet is successfully placed at our betting outlets and authorised retailers, you will receive a lottery ticket, which will serve as proof that your bet has been validly placed.
- 3.3 Singapore Pools has the full discretion to determine the maximum number of TOTO MATCH bets that you may place for each TOTO Game draw from time to

time. At the time of placing your bets, you will only be able to place up to this determined maximum number of bets.

- 3.4 Singapore Pools has full discretion to determine from time to time, the maximum and minimum limits of the stake that you may place, as well as any other conditions attached to such stake as may be notified to you through the Singapore Pools website.
- 3.5 The stake for each selected number or set of numbers in your TOTO MATCH bet shall be one (1) Singapore dollar or multiples of one (1) Singapore dollar, inclusive of Goods and Services Tax (GST). The stake payable for every lottery ticket for a TOTO MATCH bet shall be no less than one (1) Singapore dollar, inclusive of GST.
- 3.6 We are unable to guarantee the availability of your TOTO MATCH bets. Where the stake for the TOTO MATCH bet that you wish to place for a particular number or set of numbers will result in the total stake for all TOTO MATCH bets for that number or set of numbers exceeding the maximum stake that can be accepted by Singapore Pools for that particular number or set of numbers for a particular draw of the TOTO Game (“**Threshold**”), your TOTO MATCH bet will automatically be placed for the value of the stake that will result in the total stake for all TOTO MATCH bets for that number or set of numbers meeting but not exceeding the Threshold. The Threshold for each number or set of numbers for each draw of the of the TOTO Game will be determined by Singapore Pools in its sole and absolute discretion.

4. Matching of Winning Numbers and Prize Monies

- 4.1 The Winning Numbers are determined in the manner stated in the TOTO Game Rules. Singapore Pools has full discretion over the decision on how the Winning Numbers of each TOTO Game draw are to be decided.
- 4.2 Official information on the Winning Numbers drawn for the relevant TOTO Game draw to which your TOTO MATCH Entry(ies) correspond will be released by us on the Singapore Pools website and mobile app. Singapore Pools reserves the right to rectify any errors discovered after the official information has been released on our website and mobile app, and the Winning Numbers of the relevant draw will be as stated in the latest rectified version. Otherwise, the Winning Numbers of the relevant draw shall be as announced on the Singapore Pools website and mobile app at the end of the relevant draw.

- 4.3 The prize amounts for the different types of TOTO MATCH Entries are as described below:

Type of Entry	Prize Amount for every \$1 stake
MATCH ADDITIONAL NUMBER Entry	\$30
MATCH 2 Entry	\$50
MATCH 3 Entry	\$500
MATCH 4 Entry	\$7,000

- 4.4 If your lottery ticket contains a winning TOTO MATCH Entry (see Clause 2.2 above) for the particular draw of the TOTO Game for which your lottery ticket is valid, you shall be entitled to a winning prize.

5. Irregularities

- 5.1 Refunds are not available for any TOTO MATCH bet made in respect of any draw of the TOTO Game, save that if a force majeure event occurs, we may at our sole and absolute discretion either choose to refund the stake paid, or postpone the relevant TOTO Game draw to which the TOTO MATCH bet corresponds to a later date, in which event no refunds will be given. We will only grant refunds if we are satisfied at our sole and absolute discretion that your claim is valid. Where there is any non-compliance of regulatory requirements in respect of a particular draw, such draw may be postponed but no refunds will be issued.

For purposes of this clause, a force majeure event refers to any event beyond the reasonable control of Singapore Pools, including but not limited to strikes and labour disputes, accidents, war, invasion, riot, rebellion, civil commotion, insurrection, fire, flood, high winds, lightning, changes in law, national or state emergencies or other governmental actions, epidemic, disease, explosion, act of God or embargoes.

- 5.2 Where there is evidence of any rigging of any draw which is the subject of any bet placed with Singapore Pools, we reserve the right to do any or all of the following:
- Delay the announcement of the results of the affected draws,
 - Withhold payment of the relevant prizes pending the outcome of any investigation into the suspected rigging.
 - Withhold payment of the relevant prizes pending verification of the suspected rigging.
 - Declare bets on the relevant draw as void. In such an event, all bets for the relevant draw will be refunded.
- 5.3 If a fault or failure occurs in the equipment used for a draw in the course of the relevant TOTO Game draw to which your TOTO MATCH bet corresponds, Singapore Pools shall have absolute discretion to determine the validity of the draw. For instance, Singapore Pools may declare that any and all numbers that have been drawn were duly and validly drawn, or declare that the draw is void and commence

a new draw whether using the same equipment or otherwise. If a draw has been declared to be void by Singapore Pools, this draw shall be treated as if it has never taken place, and all TOTO MATCH bets placed for this particular draw shall be refunded.

- 5.4 For the avoidance of doubt, any irregularity or circumstance which invalidates or voids the relevant TOTO Game draw to which your TOTO MATCH bet corresponds shall result in the invalidation or voiding of your bet.
- 5.5 Where any error or miscalculation of any prize is discovered at any time, Singapore Pools shall be empowered at our sole and absolute discretion to declare a revised prize.
- 5.6 Where a revised prize is declared by Singapore Pools in respect of your winning lottery ticket:
- a) If you have not previously been paid a prize in respect of your winning lottery ticket, you shall be paid the full revised prize.
 - b) Where you have been paid the original prize and the revised prize is higher in value than the original prize, you shall be entitled to claim the difference between the original prize and the revised prize, subject to any reasonable conditions of payment which Singapore Pools may impose at our sole and absolute discretion.
 - c) If you have failed to present yourself for the collection of the revised prize or the difference between the original prize and the revised prize by the expiration of the time specified by Singapore Pools as stated on the Singapore Pools website and mobile app for the payment of the revised prize, or otherwise failed to adequately identify yourself to our satisfaction or to accept our conditions of payment (if any), the unclaimed revised prize or difference shall be forfeited.
 - d) Where you have been paid the original prize and the revised prize is lower in value than the original prize, Singapore Pools shall be entitled to recover the difference from you.

6. General Provisions

- 6.1 These TOTO MATCH Game Rules shall apply to TOTO Game Draw No. 4086/2025 and all subsequent TOTO Game draws where Singapore Pools draws the Winning Numbers for a draw.
- 6.2 By placing a TOTO MATCH bet, you agree to be bound by these TOTO MATCH Game Rules.
