

Football Betting Game Rules w.e.f. 29 May 2026, 00:00 hrs



In accordance with Section 70(1) of the Gambling Control Act 2022, the Gambling Regulatory Authority of Singapore approves the game rules in respect of the game “Football Betting” as set out in this document by Singapore Pools (Private) Limited.

**GAME RULES FOR FOOTBALL BETTING
("FOOTBALL BETTING GAME RULES")**

The following Rules are laid down by Singapore Pools (Private) Limited ("Singapore Pools", "we", "us" or "our") for Football Betting.

1. Objective

- 1.1 In Football Betting, you are placing a wager on any one of the possible outcomes of a football event under a selected bet type offered by Singapore Pools. A betting ticket includes both physical tickets issued offline for bets placed physically, as well as digital records and e-tickets issued for bets placed via remote betting. To qualify for a winning prize, your selected outcome on your betting ticket must correspond to the result of the relevant football event that is declared by us to be the winning selection.

2. How to Play

- 2.1 In Football Betting, you are essentially placing wagers on possible events and outcomes relating to all or part of the duration of a football match and/or a Championship (as defined in the **Appendix**) ("**Football Event**"). More information on the rules and bet types applicable to Football Betting is set out in the **Appendix**.

3. Placing your bets

- 3.1 You are able to place your bets for Football Betting either (a) physically at our betting outlets and authorised retailers; or (b) remotely through our website and mobile app.
- 3.2 Bets may be placed before the commencement of the Football Event. Singapore Pools may offer betting up to sixty (60) days, or such shorter time as determined by Singapore Pools, prior to the commencement of the Football Event until the prescribed time for the closure of the bet placement period as may be determined by Singapore Pools in its sole and absolute discretion. Bets may also be placed while the Football Event is in progress should live betting be offered by Singapore Pools for the Football Event. For the avoidance of doubt, the offering of live betting for a Football Event is in our sole and absolute discretion, and we may stop offering live betting at any time even if live coverage for a Football Event is or continues to be offered. If a bet is successfully placed at betting outlets and authorised retailers, you will receive a betting ticket, which will serve as proof that your bet has been validly placed. If a bet is successfully placed through your verified account that is opened and operated by Singapore Pools for the

purpose of remote betting (“**Remote Betting Account**”) via the Singapore Pools website and mobile app, you will receive a confirmation that your bet has been successfully placed. The bet will be recorded in your Remote Betting Account, and such record will serve as proof that your bet has been validly placed. Your bet will be deemed to be valid and accepted by Singapore Pools only if full payment has been made for the requisite stake amount for your bet. If such full payment is not made, the bet will be invalid and rejected by Singapore Pools. It is your responsibility to ensure that the data printed on the physical betting ticket, e-ticket or recorded in the Remote Betting Account are in accordance with your instructions.

- 3.3 Depending on the Football Event in question, selected bet types may be offered for betting at the sole and absolute discretion of Singapore Pools at any point in time, including before the start of and/or during the relevant Football Event.
- 3.4 Unless otherwise provided in these Football Betting Game Rules, Singapore Pools shall, at our sole and absolute discretion, determine the odds applicable to each selection for a particular bet type at the time when we begin to accept bets in respect of a particular Football Event. We may, at our sole and absolute discretion, vary the said odds from time to time until such time that we cease to accept bets in respect of the particular Football Event. For the avoidance of doubt, the acceptance of a bet at any particular odds by Singapore Pools shall not oblige us to accept any other bet on the same selection at the same odds.
- 3.5 The amount you are wagering for each bet (otherwise known as the “**stake**”) shall be in multiples of one (1) Singapore dollar, except that where a bet is placed through remote betting channels, the stake need not be in multiples of one (1) Singapore dollar so long as it is expressed in whole dollars and cents and complies with the minimum stake requirements set out in Clause 3.6(b). Goods and Services Tax (GST) is payable on the stake for a betting ticket. You may make payment of the stake and GST thereon by way of any of the modes of payment which Singapore Pools may, in its sole and absolute discretion, accept from time to time, including but not limited to payment by way of the use of betting vouchers which may be issued by Singapore Pools and in accordance with the terms and conditions governing the usage of such betting vouchers.
- 3.6 The minimum stake payable for every betting ticket for Football Betting shall be as follows:
 - a) If the bet is placed at betting outlets and authorised retailers, the minimum stake payable shall be no less than five (5) dollars, except for the Multiples bet type where the stake payable shall be no less than one (1) dollar; and
 - b) If the bet is placed through remote betting, the minimum stake payable shall be no less than one (1) dollar.
- 3.7 Singapore Pools has the full discretion to determine the maximum number of bets that you may place from time to time. At the time of placing your bets, you will only be able to place up to this determined maximum number of bets.
- 3.8 Singapore Pools has full discretion from time to time, to determine the maximum and minimum limits of the stake that you may place, as well as any other

conditions attached to such stake as may be notified to you through the Singapore Pools website or mobile app.

4. Prizes – Declaration of Winnings

- 4.1 Official information on the results of the relevant Football Event will be released by us on the Singapore Pools website as and when such results are available to us. We reserve the right to rectify any errors discovered after the official information has been released on the Singapore Pools website, and the results of the relevant Football Event will be as stated in the latest rectified version on the Singapore Pools website. Otherwise, the results of the relevant Football Event shall be as announced on the Singapore Pools website.
- 4.2 Unless otherwise provided in these Football Betting Game Rules (including but not limited to where Cash Out (as defined in the **Appendix**) is available for your bet), to qualify for a winning prize, your selected outcome on your betting ticket for a particular bet type in respect of a Football Event must correspond to the result which is declared by Singapore Pools to be the winning selection for the said bet type.
- 4.3 Unless otherwise provided in these Football Betting Game Rules (including but not limited to where Cash Out (as defined in the **Appendix**) is available for your bet and you have submitted a Cash Out request that is accepted by us), the prize in respect of your bet shall be the amount stated to be as such on your betting ticket, or the amount as may be computed based on the relevant stake and the odds of your bet. For the avoidance of doubt, where a betting ticket has been issued in respect of your betting selection, any variation in the odds thereafter of your betting selection shall not affect the prize in respect of your bet as encapsulated in your betting ticket.
- 4.4 In the event of a Dead Heat, i.e. a situation where two or more competitors or players achieve identical results for a betting event, the winning prize shall be calculated by dividing the stake placed on the selection involved in the Dead Heat by the number of competitors or players who achieved the identical result, and then multiplying the divided amount by the odds applicable to the selection.

5. Irregularities

A. Refunds

- 5.1 Refunds are not available for any purchases made in respect of Football Betting, save where provided for in these Football Betting Game Rules. Various scenarios in which refunds will be made available are set out below.
- 5.2 Subject to any contrary provisions within these Football Betting Game Rules, Singapore Pools will refund you for bets placed on a Football Event, if no result has been declared by us for the relevant bet type of your bets in the following scenarios which will render the bets void:

- (a) The venue is changed after the start of betting but before the commencement of the Football Event; or
 - (b) The Football Event is called off (including but not limited to abandonment, postponement, suspension and cancellation) after the start of betting, and where, at the time that Singapore Pools declares or announces its decision on how to treat the bets involved:
 - i. No replay or resumption of the Football Event has been scheduled;
 - ii. A replay or resumption of the Football Event has been scheduled, but the venue of the Football Event has changed; or
 - iii. A replay or resumption of the Football Event has been scheduled, but the date of such replay or resumption does not fall within 36 hours of the original scheduled time and date of the Football Event.
- 5.3 For the avoidance of doubt, the late start of a Football Event does not constitute postponement or the calling off of a Football Event, provided that the start time of the Football Event falls within 12 hours of the original scheduled start time and there has been no change in the venue.
- 5.4 Where a Football Event has been called off (including but not limited to abandonment, postponement, suspension and cancellation) and Singapore Pools announces that a replay or resumption of the Football Event shall take place in lieu of the originally scheduled Football Event, Singapore Pools may, at our sole and absolute discretion, extend the deadline for accepting any bets in respect of the Football Event, or if betting has already closed for the Football Event, to allow for a fresh round of betting for the Football Event.
- 5.5 Where the start date and/or time of any Football Event is brought forward such that it occurs before the deadline determined by Singapore Pools at our sole and absolute discretion to constitute the close of betting for the said Football Event, then the close of betting for the Football Event shall be deemed to be immediately prior to the new start date and/or time of the Football Event. All bets placed with and accepted by us after such deemed close of betting shall be null and void, and we will make refunds for all such bets placed for the Football Event.
- 5.6 Clause 5.5 shall not apply where Singapore Pools has determined that the close of betting shall be after the start date and/or time of the Football Event. In this situation, you may continue to place bets during the Football Event up till the close of betting at such date and/or time as determined by Singapore Pools at our sole and absolute discretion.
- 5.7 Singapore Pools will make refunds for any bets for Football Betting which have been declared to be null and void. Refunds may also be available in respect of specific bet types where provided for in the **Appendix**.
- 5.8 Notwithstanding and without prejudice to any other provision in these Football Betting Game Rules, Singapore Pools may pay refunds for any bets in respect of any Football Event, including but not limited to refunds for bets placed after the

close of betting, where Singapore Pools so determines at our sole and absolute discretion, without needing to give any reasons for doing so.

B. Other Irregularities

- 5.9 Where there is any uncertainty relating to the results of any Football Event, we reserve the right to suspend the settlement of all affected bets pending the verification and confirmation of the results of the relevant football event.
- 5.10 Where there is evidence of any rigging of any Football Event which is the subject of any bet placed with Singapore Pools, we reserve the right to do any or all of the following:
- a) Delay the announcement of the results of the affected Football Events;
 - b) Withhold payment of the relevant prizes pending the outcome of any investigation into the suspected rigging;
 - c) Withhold payment of the relevant prizes pending verification of the suspected rigging;
 - d) Declare bets on the relevant event as void. In such an event, all bets on the relevant event shall be refunded.
- 5.11 Where Singapore Pools has reason to believe or suspect that a live bet has been placed after the outcome of a live Football Event is known, or if delayed or lagged “live” television coverage results in a live bet being placed after you have gained an advantage at our sole and absolute opinion, we shall be entitled to treat the bet as void without being obliged to provide any reason whatsoever.
- 5.12 In the event of any disqualification, objection, appeal, official inquiry, application to amend scores or other protest of any nature whatsoever: -
- a) in respect of any Football Event; or
 - b) which affect the scores or results of said Football Event,
- Singapore Pools may, at our sole and absolute discretion, disregard such protest, treat such protest as invalid, and declare the final outcome of the various bet types in respect of the relevant Football Event in accordance with the scores or result reached, immediately upon the conclusion of the relevant Football Event, or prior to the making of the relevant protest. Such final outcome shall not be affected by any subsequent review or modification of the score or result of the relevant Football Event as a consequence of or in connection with such protest.
- 5.13 Where any error or miscalculation of any prize is discovered at any time, Singapore Pools shall be empowered at our sole and absolute discretion to declare a revised prize.
- 5.14 Where a revised prize is declared by Singapore Pools in respect of your winning betting ticket:

- a) If you have not previously been paid a prize in respect of your winning betting ticket, you shall be paid the full revised prize.
- b) Where you have been paid the original prize and the revised prize is higher in value than the original prize, you shall be entitled to claim the difference between the original prize and the revised prize, subject to any reasonable conditions of payment which Singapore Pools may impose at our sole and absolute discretion.
- c) If you have failed to present yourself for the collection of the revised prize of the difference between the original prize and the revised prize by the expiration of the time specified by Singapore Pools for the payment of the revised prize, or otherwise failed to adequately identify yourself to our satisfaction or to accept our conditions of payment, the unclaimed revised prize or difference shall be forfeited.
- d) Where you have been paid the original prize and the revised prize is lower in value than the original prize, Singapore Pools shall be entitled to recover the difference from you.

6. General Provisions

- 6.1 These Football Betting Game Rules shall apply to all bets placed on or after 29 May 2026.
- 6.2 By placing a bet for Football Betting, you agree to be bound by these Football Betting Game Rules and the Appendix.

APPENDIX TO FOOTBALL BETTING GAME RULES

1. Definitions

1.1 The following definitions are relevant for the purposes of Football Betting:

- (a) **“0 Goal”** means no Valid Goals were scored in a football match.
- (b) **“Away Team”** means the team that is mentioned second in any table published by Singapore Pools for the purposes of Football Betting, or such team which we specifically describe as the “Away Team”.
- (c) **“Cash Out”** means the feature or option that allows you to settle your bet(s) before the result (i.e. the winning selection / outcome) for the particular bet type is declared by us, and which may be offered by us from time to time and on such bet types, betting selections and Football Events as we may decide in our sole and absolute discretion.
- (d) **“Cash Out Amount”** means the amount payable by us to you in respect of your Cash Out request as at the time that such Cash Out request is accepted by us.
- (e) **“Championship”** refers to a specified football championship, League, Tournament or other football competition.
- (f) **“Defined List”** refers to the selection of matches Singapore Pools publishes for the various bet types described below at Appendices A1 to A63.
- (g) **“Extra Time”** means the scheduled additional 30 minutes of play or other duration as may be decided by the match officials plus stoppage or added time upon the conclusion of the Regulation Time.
- (h) **“Extra Time Score”** means the Score of a football match for only the Extra Time of the match. For the avoidance of doubt, the Extra Time Score shall expressly exclude the Full Time Score.
- (i) **“First Half”** means the scheduled first 45 minutes of play commencing from kickoff of the football match, plus stoppage or added time.
- (j) **“First Half Score”** means the Score of a football match as at the end of the First Half.
- (k) **“Full Time Score”** means the Score of a football match as at the end of Regulation Time. For the avoidance of doubt, the Full Time Score shall not include any goals scored in Extra Time or as a result of a penalty shoot-out.

- (l) “**Group**” means a grouping of football teams participating in a Championship as determined by the organisers of the Championship.
- (m) “**Handicap**” means an advantage or disadvantage, expressed in either fractions, decimals or whole numbers, as determined by Singapore Pools and conferred upon any team. In a bet type involving a Handicap, you will select the value of the Handicap and the team on which the Handicap will be applied to. The Handicap will then be applied to the Valid Goals scored by that team when determining whether you have won the bet.
- (n) “**Home Team**” means the team that is mentioned first in any table published by Singapore Pools for the purposes of Football Betting, or such team which we specifically describe as the "Home Team".
- (o) “**League**” means a football league comprised of multiple football teams which will play against each other in a league format.
- (p) “**Own Goal**” means a goal scored by a player from one team against his own team, which will be registered as a goal in favour of the opposing team.
- (q) “**Regulation Time**” means both the First Half and the Second Half. For the avoidance of doubt, Regulation Time excludes any allocated Extra Time or time for the execution of penalty shootouts.
- (r) “**Return**” means the amount payable by Singapore Pools to you in the event that your betting selections with the results as declared by us, which, save as expressly provided in Appendices A1 to A63 below, shall be the amount determined by multiplying the stake by the prevailing odds applicable to the betting selection at the time the bet is placed. For the avoidance of doubt, the prize shall include the stake in respect of that bet, i.e. you will win only the prize, and will not be given a refund of your stake.
- (s) “**Second Half**” means the scheduled second 45 minutes of play after the First Half, plus stoppage or added time.
- (t) “**Second Half Score**” means the Score of a football match for only the Second Half. For the avoidance of doubt, the Second Half Score shall expressly exclude the First Half Score and the Full Time Score.
- (u) “**Score**” means the score counting Valid Goals, unless otherwise specified for a particular bet type set out in Appendices A1 to A63 below.
- (v) “**Tournament**” means a specified football competition which comprises various stages, including the semi-finals and finals.
- (w) “**Valid Corner**” means a corner kick which is awarded by the referee in the football match and which is taken by the team to which the corner kick was awarded to. Corner kicks awarded but not taken are not considered Valid Corners.

- (x) “**Valid Goal**” means a goal scored in a football match other than as a result of a penalty shootout that takes place after the end of Extra Time. For the avoidance of doubt, a penalty, free kick or Own Goal scored within Regulation Time or Extra Time is a Valid Goal.

2. General Terms

- 2.1 The various bet types available for Football Betting are as set out in Appendices A1 to A63 below.
- 2.2 For each bet type, we shall, at our sole and absolute discretion, determine the selections available for placing bets on. We are also entitled to adjust said selections as and when we deem it necessary to do so.
- 2.3 Where a football match is abandoned after it has proceeded beyond Regulation Time (including when the match has proceeded to Extra Time or the execution of penalty shootouts), there shall be no refunds for the bets placed for such football match, and the Full Time Score of such football match shall be used to determine the result.
- 2.4 Where a football match or Championship is called off (including but not limited to abandonment, postponement, suspension and cancellation) or restructured (including but not limited to changes to the competition rules, format or match-up), the validity of the bets placed depend on the particular bet type made. You may refer to the Appendices below for more information on whether the bets placed in respect of a particular bet type are valid in such an event.
- 2.5 Notwithstanding any provisions to the contrary in the Appendices below, if any football match or Championship is cancelled or restructured such that the results for the relevant bet types cannot be determined as originally scheduled or contemplated, Singapore Pools shall be entitled to deal with any bet placed in respect of the football match or Championship in such manner as it deems fit at our sole and absolute discretion. You may check the Singapore Pools website for updates in such an event.
- 2.6 Any player, official or volunteer registered, employed, deployed or appointed by any entity participating in the competitions in Singapore known as the Singapore Premier League and the Singapore Cup (and any successor competitions thereof) is not allowed to place any bet in these competitions or any other competitions which their entity participates in whether in Singapore or elsewhere. In addition, any official, staff or volunteer of the Football Association of Singapore who may be in a position to influence the outcome of a football match, whether directly or indirectly, including by way of abetting, aiding, instigating or conspiring with others is not allowed to place any bets on that football match.

3. Cash Out

- 3.1 Cash Out is only available if you place bets through your Remote Betting Account. The option to automatically or partially Cash Out your bet is not available.
- 3.2 Cash Out may be offered at our sole and absolute discretion at any point in time. We are not obliged to offer Cash Out on any bet type, betting selection or Football Event, and we will not be responsible if Cash Out is not available for any reason or at any time.
- 3.3 The Cash Out Amount shall be determined by us in our sole and absolute discretion. For the avoidance of doubt, Cash Out Amount is subject to change at any time from the time that you make the Cash Out request until your Cash Out request has been accepted by us.
- 3.4 We may, in our sole and absolute discretion, at any time, and without offering any explanation:
 - (a) Amend, suspend, remove or update the Cash Out option offered in respect of any bet type, betting selection or Football Event;
 - (b) Decline to accept your Cash Out request, including where the Cash Out option is not available for the bet type, betting selection or Football Event that your Cash Out request relates to;
 - (c) Declare void and reverse the settlement of the Cash Out or otherwise declare a revised Cash Out Amount for any reason, including without limitation, in the event that the settlement of a Cash Out was made pursuant to an error or miscalculation;
 - (d) Remove all or part of a Cash Out option available to you if we reasonably believes that you are or have been misusing or abusing the Cash Out option; and/or
 - (e) Withdraw or suspend your eligibility to use the Cash Out option on a temporary or permanent basis.
- 3.5 Where Cash Out is available before the start of a Football Event and we do not cover or stop covering the Football Event for live betting, then Cash Out will be unavailable once the Football Event starts or when the live betting coverage stops. Cash Out will not be available when the market for the bet type, betting selection or Football Event is suspended. For the avoidance of doubt, there shall be no refunds for your bets placed due to and/or arising out of the unavailability of the Cash Out option for any reason or at any time.
- 3.6 Once your Cash Out request has been accepted by us, your bet is considered as fully and finally settled by us, and the subsequent result (i.e. the winning selection / outcome) for the relevant bet type as declared by us shall not affect your Cash Out Amount.

- 3.7 There is a time delay between the time that you submit your Cash Out request and the time of acceptance of your Cash Out request by us. A Cash Out request will only be valid if and when it is accepted by us. Any change in any circumstances relevant to the bet type, betting selection or Football Event in respect of which Cash Out is made available, or in any relevant prices or odds, before the Cash Out request is accepted by us, may result in your Cash Out request being rejected. Where your Cash Out request is rejected by us due to such changes, you may submit a new Cash Out request (if available) at the prevailing prices or odds.
- 3.8 Where we exercise our right to suspend or remove the Cash Out option or where we decline to accept your Cash Out request or declare void any settled Cash Out transaction, your bet as originally placed on such bet type, betting selection or Football Event in respect of which the Cash Out option is made available will stand, i.e. the status of your original bet placed will not change.

Appendix A1 – 1x2

Bet Type	“1x2” refers to the type of betting where you bet on the outcome of a football match at the end of Regulation Time.
Selections available for betting	• Win by the Home Team based on Full Time Score (i.e. Home Team scores more goals than the Away Team at the end of Regulation Time) • Draw between the Home Team and the Away Team based on Full Time Score (i.e. both teams score the same number of goals or the football match remains goalless at the end of Regulation Time) • Win by the Away Team based on Full Time Score (i.e. Away Team scores more goals than the Home Team at the end of Regulation Time)
Winning selection	You have a winning selection if you have correctly selected the outcome of the football match at the end of Regulation Time.
Refund of Bets / Special Provisions	Where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of Regulation Time, the bets for “1x2” on that match shall be void and refunded.

Appendix A2 – Halftime 1x2

Bet Type	“Halftime 1x2” refers to the type of betting where you bet on the outcome of the First Half of a football match.
Selections available for betting	• Win by the Home Team based on First Half Score (i.e. Home Team scores more goals than the Away Team in the First Half) • Draw between the Home Team and the Away Team based on First Half Score (i.e. both teams score the same number of goals or the football match remains goalless in the First Half) • Win by the Away Team based on First Half Score (i.e. Away Team scores more goals than the Home Team in the First Half)
Winning selection	You have a winning selection if you have correctly selected the outcome of the First Half of the football match.
Refund of Bets / Special Provisions	Where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) after the completion of the First Half but before the completion of the Second Half, bets for “Halftime 1x2” shall be treated as valid notwithstanding the calling off of the match. However, where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) at any time before the First Half is completed, bets for “Halftime 1x2” shall be void and refunded. Illustration:

	• In the match Portugal vs Russia, the First Half Score is 2-0. The match was abandoned at the 77th minute. Bets for “Halftime 1X2” will be valid and the winning selection for “Halftime 1x2” will be Portugal. • In the match Nigeria vs Ghana, the match was abandoned at 30th minute during the First Half with a score of 0-0. Bets for "Halftime 1x2" will be void and refunded.

Appendix A3 – Full Time Pick the Score (PTS)

Bet Type	“Full Time PTS” refers to the type of betting where you bet on the exact score of a football match at the end of Regulation Time.																																										
Selections available for betting	You will be able to select from a list of possible Full Time Score outcomes, as well as an option known as Any Other Score (“AOS”), which encompasses all scores not within the list of possible Full Time Score outcomes.																																										
Winning selection	You have a winning selection if your bet is (1) the same as the Full Time Score; or (2) AOS, in the event that the Full Time Score is not in the list of possible Full Time Score outcomes.																																										
Refund of Bets / Special Provisions	Where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of the Regulation Time, the bets for “Full Time PTS” shall be void and refunded unless the result for “Full Time PTS” is already fully determined as at the point the match is being called off. Illustration 1: In the match Argentina vs USA, the match was abandoned at the 75th minute with score of 4-4. Therefore, there is no winning selection. A S\$100 bet on "England (0)" with odds of 1.80 will have total stake (S\$100) returned. A S\$100 bet on “Brazil (0)” with odds of 1.85 will have total stake (S\$100) returned.

- “Asian Handicap” where $X = -0.25$ at prevailing score of 1-0 has the following selections:
 - England (-0.25). Applying the Handicap to the Asian Handicap Adjusted Score, the final adjusted Full Time Score is therefore -0.25-0 in favour of Brazil.
 - Brazil (+0.25). Applying the Handicap to the Asian Handicap Adjusted Score, the final adjusted Full Time Score is therefore 0-0.25 in favour of Brazil.

Therefore, Brazil (+0.25) is the winning selection. A S\$100 bet on "Brazil (+0.25)" with odds of 1.85 will win with half the stake (S\$50) and have the other half of the stake (S\$50) returned if the Full Time Score is 1-0. Hence, the payout = $S\$50 \times 1.85 + S\$50 = S\$142.50$.

- "Asian Handicap" where $X = -0.5$ at prevailing score of 1-0 has the following selections:
 - England (-0.5). Applying the Handicap to the Asian Handicap Adjusted Score, the final adjusted Full Time Score is therefore -0.5-0 in favour of Brazil.
 - Brazil (+0.5). Applying the Handicap to the Asian Handicap Adjusted Score, the final adjusted Full Time Score is therefore 0-0.5 in favour of Brazil.

Where X = -1, then the selections available for betting are Home Team +(-1), i.e. (-1) and Away Team -(-1), i.e. (+1). Note: “Half Time Asian Handicap Adjusted First Half Score” means, where a bet is placed after kickoff of a football match for Half Time Asian Handicap bet type, the score between the point when the bet is placed and the end of the First Half. For example, in a match between Holland and Iceland, if the bet is placed in the 23rd minute of a football match when the score is 1-0, and the First Half Score is 2-1, the Half Time Asian Handicap Adjusted First Half Score is 1-1.

Illustration 1:

In the match England (Home Team) vs Brazil (Away Team), England wins the First Half with the First Half Score at 1-0. If the bets are placed before the kickoff of the match, the winning selection will be derived after applying the assigned Handicap(s) to the First Half Score. For example:

- “Half Time Asian Handicap” where $X = 0$ has the following selections:

- England (0). This will result in the adjusted First Half Score being 1-0 in favour of England.
- Brazil (0). This will result in the adjusted First Half Score being 1-0 in favour of England.

Therefore, England (0) will be the winning selection. A S\$100 bet on "England (0)" with odds of 1.80 will win a payout of $S\$100 \times 1.80 = S\180 .

- “Half Time Asian Handicap” where $X = -0.25$ has the following selections:

- England (-0.25). This will result in the adjusted First Half Score being 0.75-0 in favour of England.
- Brazil (+0.25). This will result in the adjusted First Half Score being 1-0.25 in favour of England.

Therefore, England (-0.25) will be the winning selection. A S\$100 bet on "England (-0.25)" with odds of 1.80 will win a payout of $S\$100 \times 1.80 = S\180 .

- “Half Time Asian Handicap” where $X = -0.5$ has the following selections:

- England (-0.5). This will result in the adjusted First Half Score being 0.5-0 in favour of England.
- Brazil (+0.5). This will result in the adjusted First Half Score being 1-0.5 in favour of England.

Therefore, England (-0.5) will be the winning selection. A S\$100 bet on "England (-0.5)" with odds of 1.80 will win a payout of $S\$100 \times 1.80 = S\180 .

- “Half Time Asian Handicap” where $X = -0.75$ has the following selections:

- England (-0.75). This will result in the adjusted First Half Score being 0.25-0 in favour of England.
- Brazil (+0.75). This will result in the adjusted First Half Score being 1-0.75 in favour of England.

Therefore, England (-0.75) will be the winning selection. A S\$100 bet on "England (-0.75)" will win with half the stake (S\$50) and have the other half of the stake (S\$50) returned. Hence, the payout = $S\$50 \times 1.80 + S\$50 = S\$140$.

A S\$100 bet on “Brazil (+0.75)” with odds of 1.85 will lose half the stake (S\$50) and have the other half of the stake (S\$50) returned. Hence, the payout = $S\$0 + S\$50 = S\$50$.

- “Half Time Asian Handicap” where $X = -1$ has the following selections:

- England (-1). This will result in the adjusted First Half Score being 0-0.
- Brazil (+1). This will result in the adjusted First Half Score being 1-1.

Therefore, there is no winning selection. A S\$100 bet on "England (-1)" will have the total stake (S\$100) returned. A S\$100 bet on "Brazil (+1)" will have the total stake (S\$100) returned.

Illustration 2:

In the match England (Home Team) vs Brazil (Away Team), England wins the First Half with the First Half Score at 1-0. After England had scored the first goal which resulted in a score of 1-0, the results for bets placed thereafter will be computed / determined based on the Half Time Asian Handicap Adjusted First Half Score of 0-0. For example:

- “Half Time Asian Handicap” where $X = 0$ at prevailing score of 1-0 has the following selections:

- England (0). Applying the Handicap to the Half Time Asian Handicap Adjusted First Half Score, the final adjusted First Half Score is therefore 0-0.
- Brazil (0). Applying the Handicap to the Half Time Asian Handicap Adjusted First Half Score, the final adjusted First Half Score is therefore 0-0.

Therefore, there is no winning selection. A S\$100 bet on "England (0)" with odds of 1.80 will have total stake (S\$100) returned. A S\$100 bet on "Brazil (0)" with odds of 1.85 will have total stake (S\$100) returned.

- “Half Time Asian Handicap" where $X = -0.25$ at prevailing score of 1-0 has the following selections:

- England (-0.25). Applying the Handicap to the Half Time Asian Handicap Adjusted First Half Score, the final adjusted First Half Score is therefore -0.25-0 in favour of Brazil.
- Brazil (+0.25). Applying the Handicap to the Half Time Asian Handicap Adjusted First Half Score, the final adjusted First Half Score is therefore 0-0.25 in favour of Brazil.

Therefore, Brazil (+0.25) is the winning selection. A S\$100 bet on "Brazil (+0.25)" with odds of 1.85 will win with half the stake (S\$50) and have the other half of the stake (S\$50) returned if the First Half Score is 1-0. Hence, the payout = $S\$50 \times 1.85 + S\$50 = S\$142.50$.

For the avoidance of doubt, where a match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of the First Half and before the Xth Valid Goal is scored, bets on “Half Time Team to Score Xth Goal” shall be void and refunded. Where a match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of the First Half but after the Xth Valid Goal is scored, bets on “Half Time Team to Score Xth Goal” shall be valid.

Illustration:

In the illustration above, if the match is called off at the 15th minute at a score 1-0, bets for "Half Time Team to Score 1st Goal" will be valid because the result is already fully determined at the point the match is called off. Bets for "Half Time Team to Score 2nd Goal" will be void and refunded because the result is not determined at the point the match is called off.

Appendix A60 – Extra Time Total Goals

Bet Type	“Extra Time Total Goals” refers to the type of betting where you bet on how many Valid Goals will be scored in total (i.e. regardless of whether Home Team or the Away Team scores the Valid Goals) in a football match according to the Extra Time Score.
Selections available for betting	• Any number of Valid Goals scored in the football match during Extra Time up to X (where “X” is a whole number starting from 1 as may be determined by Singapore Pools at our sole and absolute discretion) • More than X Valid Goals scored in the football match during Extra Time • No Valid Goals scored
Winning selection	You have a winning selection if you have correctly selected the total number of Valid Goals scored by both teams according to the Extra Time Score.
Refund of Bets / Special Provisions	Where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of Extra Time, the bets for “Extra Time Total Goals” shall be void and refunded, unless the result for “Extra Time Total Goals” is already fully determined as at the point the match is called off. Illustration 1: In the match Argentina vs USA, the match was abandoned at the 103th

minute with score of 1-0. If the selections listed for “Extra Time Total Goals” is as follow:

0	1	2+
goal	goal	goals

The result of this bet for “Extra Time Total Goals”, based on the above listed selections, cannot be determined at the point the match is called off. This is because if the match had continued, the winning selection could have been "1 Goal" or "2+ Goals". Therefore, the bets for “Extra Time Total Goals” will be void and refunded in this case.

Illustration 2:

In the match New Zealand vs Peru, the match was abandoned at the 115th minute with score of 2-0. If the selections listed for “Extra Time Total Goals” is as follow:

0	1	2+
goal	goal	goals

Score 2-0 is already beyond the list of possible “Extra Time Total Goals” outcomes. The result for “Extra Time Total Goals”, based on the above listed selections, is already fully determined to be “2+ Goals” as at the point the match is called off. Therefore, bets for “Extra Time Total Goals” will be valid in this case and the winning selection is “2+ Goals”.

Appendix A61 – Extra Time Team to Score 1st Goal

Bet Type	“Extra Time Team to Score 1st Goal” refers to the type of betting where you bet on which team will score the first goal of a football match during Extra Time.
Selections available for betting	• Home Team • Away Team • No Valid Goals scored (“No 1st Goal”)
Winning selection	You have a winning selection if (1) you have correctly selected the team which scored the first Valid Goal in the football match during Extra Time; or (2) in the event that no Valid Goals are scored in the football match during Extra Time, you selected “No 1st Goal”.
Refund of Bets / Special Provisions	• Where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) after a Valid Goal is scored, and where Singapore Pools has declared a result for “Extra Time Team to Score 1st Goal”, there shall be no refunds. • However, if there are no Valid Goals scored in the football match during the Extra Time at the time the match is called off (including but not limited to abandonment, postponement, suspension and cancellation), the bets for “Extra Time Team to Score 1st Goal” shall be void and refunded.

Appendix A62 – Extra Time Team to Score Xth Goal

Bet Type	“Extra Time Team to Score Xth Goal” refers to the type of betting where you bet on which team will score the Xth goal of a football match during Extra Time, where X is a whole number starting from 1.
Selections available for betting	• Home Team • Away Team • No Xth goal
Winning selection	You will have a winning selection if (1) you correctly selected the team which scored the Xth Valid Goal in the football match during Extra Time; or (2) in the event no Xth Valid Goal was scored in the football match during Extra Time, you selected “No Xth Goal”.
Refund of Bets / Special Provisions	• Each bet event for “Extra Time Team to Score Xth Goal” shall be closed when a goal is scored, but a new bet event may be opened by Singapore Pools at our sole and absolute discretion. Illustration: In a match between Brazil and England, the Full Time Score is 0-0. “Extra Time Team to Score 1st Goal” is opened because the next Valid Goal to be scored will be the 1st Valid Goal of Extra Time.

	When Brazil scored the 1st Valid Goal of Extra Time at 99th minute to make the score 1-0, “Extra Time Team to Score 1st Goal” will be closed, but Singapore Pools may open “Extra Time Team to Score 2nd Goal” because the next Valid Goal to be scored will be the 2nd Valid Goal of Extra Time. Where a football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of Extra Time, bets for “Extra Time Team to Score Xth Goal” shall be void and refunded unless the result is already fully determined as at the point the match is called off. Where a match is called off (including but not limited to abandonment, postponement, suspension and cancellation) during Extra Time after the Xth Valid Goal is scored in Extra Time, bets on “Extra Time Team to Score Xth Goal” shall be valid. Illustration: In the illustration above, if the match is called off at the 96th minute at a score 1-0, bets for "Extra Time Team to Score 1st Goal" will be valid because the result is already fully determined at the point the match is called off. Bets for "Extra Time Team to Score 2nd Goal" will be void and refunded because the result is not determined at the point the match is called off.

Appendix A63 – Extra Time - Will Both Teams Score

Bet Type	“Extra Time - Will Both Teams Score” refers to the type of betting where you bet on whether each team will score at least one Valid Goal during Extra Time of a football match.
Selections available for betting	- Yes - No
Winning selection	You have a winning selection if you have correctly selected whether each team will score at least one Valid Goal in a football match during Extra Time or not.
Refund of Bets / Special Provisions	Where the football match is called off (including but not limited to abandonment, postponement, suspension and cancellation) before the end of the Extra Time, the bets for “Extra Time - Will Both Teams Score” shall be void and refunded, unless the result for “Extra Time - Will Both Teams Score” is already fully determined at the point the match is called off. Illustration 1: In a match between Japan and England, where the Full Time Score was 0-0, the match was abandoned during the Extra Time at an Extra Time Score of 1-1. Bets for "Extra Time - Will Both Teams Score" will be valid with winning selection "Yes". This is because at the point of abandonment, both Japan and England had already scored at least one Valid Goals each during the Extra Time.

Illustration 2:

In a match between Australia and Sweden, the match was abandoned during the Extra Time at a score of 1-0. Bets for "Extra Time - Will Both Teams Score" will be void and refunded. This is because at the point of abandonment, only Australia had scored at least one Valid Goal during the Extra Time, and if the match had continued, it is possible that Sweden may have scored a Valid Goal as well during the Extra Time, thus affecting the winning selection for "Extra Time - Will Both Teams Score".
