- 1.2 This document amends and supersedes in its entirety the list of designated tourist attractions dated 26 November 2016, bearing reference GRA/N/24/0005, with effect from **26 January 2024**.
- 1.3 All terms used in this document, unless the context otherwise requires or otherwise defined, shall have the same meanings as in the Casino Control Act 2006 and any regulations made thereunder.
